### SECTION 4.HEALTH HAZARD INFORMATION

1. Eye contact

### SECTION 5.FIRE FIGHTING MEASURES

3. Special protective actions for fire-fighters :  
Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.
4. Special protective equipment for fire-fighters :  
Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire.  
No action shall be taken involving any personal risk or without suitable training.
