SECTION 4. HEALTH HAZARD INFORMATION

- Eye contact

SECTION 5.FIRE FIGHTING MEASURES

4. Special protective equipment for fire-fighters :

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire.
No action shall be taken involving any personal risk or without suitable training.
Move containers from fire area if this can be done without risk.
Use water spray to keep fire-exposed containers cool.

SECTION 6.ACCIDENTAL RELEASE MEASURES

- For non-emergency personnel : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. - Methods and material for containment and cleaning up
 - Small spill : Stop leak if without risk. Move containers from spill area.
Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.
 - Large spill : Stop leak if without risk. Move containers from spill area.

SECTION 7.HANDLING AND STORAGE

- Precautions for safe handling
 - Protective measures : Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. 2. Hygiene measures :
